THE POSTAL RELATIONSHIP BETWEEN THE KINGDOM OF ITALY AND THE AUSTRIAN EMPIRE-1861/1875

The aim of the exhibit is to show the mutual postal exchange between Italy and Austria from the birth of the Kingdom of Italy (March 17, 1861) up to the advent of the GPU (June 30, 1875).

During this period of fourteen years, we first meet covers franked only to the mutual border or sent "via Switzerland" unpaid or paid to destination; then, from May 15, 1862, we come back to the old 1854 Austro/Sardinian Convention with covers paid to destination and different rates according to the distances; due to the outbreak of the Third Independence War (Summer 1866) the postal relationships were interrupted and covers had to be sent through Switzerland; after the end of the war (September 1866) the earlier situation returns but with different borders due to the loss of Venetia by Austria; finally, from October 1, 1867 a new Convention came into use with uniform rates and a reduced rate for neighboring offices.

The exhibit is divided into six chapters as follows:

- March 17, 1861 to May 14, 1862: covers franked only to border or "via Switzerland"
 I-1 Covers from the Kingdom of Italy to the Austrian Empire;
 I-2 Covers from the Austrian Empire to the Kingdom of Italy.
- II May 15, 1862 to middle June 1866: resumption of the 1854 Sardinian Convention
 II-1 Covers from the Kingdom of Italy to the Austrian Empire;
 II-2 Covers from the Austrian Empire to the Kingdom of Italy.
- Middle June to early September 1866: postal relationship interrupted owing to the outbreak of the III Independence War; covers sent "via Switzerland"
 III-1 Covers from the Kingdom of Italy to the Austrian Empire;
 III-2 Covers from the Austrian Empire to the Kingdom of Italy.
- IV Early September 1866 to September 30, 1867: resumption of the 1862 Convention IV-1 Covers from the Kingdom of Italy to the Austrian Empire; IV-2 Covers from the Austrian Empire to the Kingdom of Italy.
- V October 1, 1867 to June 30, 1875: new Austro-Italian Convention
 V-1 Covers from the Kingdom of Italy to the Austrian Empire;
 V-2 Covers from the Austrian Empire to the Kingdom of Italy.
- VI 1861 to June 30, 1875: mutual exchange of foreign letters to or over each other's borders
 V-1 Austrian mediation on Italian or Foreign covers sent to or beyond Austria;
 V-2 Italian mediation on Austrian or Foreign covers sent to or beyond Italy.

Highlights (double red framed):

multicolour franking, special services, reduced rates, first day covers, "via Switzerland" routings, exotic origins or destinations; provisional use of Austrian stamps in the liberated Venetia.

Single letter rate (10gr.) paid to the Italian border, from Toscolano (21.2.62) to Riva. Charged 5Nkr on delivery in Austria for the first inland distance, up to 75km. from the border.

Single letter rate paid to the Italian border from Milan (27.5.61) to Mantua. Charged 5Nkr on delivery in Lombardy -Venetia for the first inland distance, up to 75km. from the border.



20cents Single letter rate paid to the Italian border from Bologna (22.3.62) to Venice. Charged 5Nkr on delivery in Lombardy-Venetia for the first inland distance, up to 75km. from the border.



5grana (20cents) Single letter rate paid to the Italian border from Maddaloni (8.5.62) to Padua, franked with the special stamps in use on the Neapolitan Provinces. Charged 5Nkr on delivery in Lombardy-Venetia for the first inland distance, up to 75km. from the border.



10grana(40cents) Double letter rate paid in cash (signed on the back) to the Italian border, from Palermo (30.4.61) to Venice. Charged 10Nkr on delivery in Austria for the second inland distance, up to 150km, from the border. Double Italian letters, over 10 grams of weight, could be charged on delivery as single Austrian rate (one Austrian lot = 17,5 gr.). Last day before introduction of Sardinian stamps in Sicily.

20cents Single letter rate paid to the Italian border from Palermo (1.10.61) to Venice. Charged 10Nkr on delivery in Lombardy-Venetia for the second inland distance, up to 150km. from the border. The stamps cancelled with the red linear "DA SICILIA" at Gencs.



20cents Single letter rate paid to the Italian border from Florence (27.5.61) to Venice. Charged 10Nkr on delivery in Lombardy-Venetia for the second inland distance, up to 150km. from the border.



20cents Single letter rate paid to the Italian border from Florence (28.5.61) to Venice. Charged 10Nkr on delivery in Lombardy-Venetia for the second inland distance, up to 150km. from the border. Till the second half of 1861, the distances from the border were countered from entry at Desenzano/Peschiera and not from the nearest entry of Pontelagoscuro/Occhiobello.



20cents Single letter rate paid to the Italian border from Ferrara (13.3.62) to Trieste. Charged 15Nkr on delivery in Austria for the third inland distance, over 150km. from the border.



Double letter rate paid to the Italian border from Milan (29.12.61) to Brünn. Charged 15Nkr on delivery in Austria for the third inland distance, over 150km. from the border. Double Italian letters, over 10 grams of weight, could be charged on delivery as single Austrian rate (one Austrian lot = 17,5)

5grana(20cents) Single letter rate paid to the Italian border from Molfetta (22.5.61) to Trieste, with the special stamps in use on the Neapolitan Provinces.

Charged 15Nkr on delivery in Austria for the third inland distance, over 150km, from the border.



10grana(40cents) Double letter rate paid to the Italian border from Molfetta (21.6.61) to Trieste, with the special stamps in use on the Neapolitan Provinces. Charged 15Nkr on delivery in Austria for the third inland distance, over 150km. from the border. Double Italian letters, over 10 grams of weight, could be charged on delivery as single Austrian rate (one Austrian lot = 17,5 gr.).





Double registered letter rate paid to the Italian border from Milano (26.10.61) to Mestre. Charged 10Nkr on delivery in Veneto as double weight for the first inland distance, up to 75km. from the border. Delivered as not registered mail. From the second half of 1861 the inland Austrian distance was countered from the nearest border and not from Desenzano.



Printed matter paid to destination from Milan (20.10.61) to Udinc. In this period the wrappers and the printed matters where exchanged free of charge on delivery.



5cents Printed matter insufficiently paid (2cents) from Ancona (10.4.62) to Venice. Charged 10Nkr on delivery as cover for the second Austrian distance; refused and sent back to Ancona; franked with 3cents more, marked on the front with St. Andrew's cross indicating payment to destination and delivered free of charge. In this period printed matters are always delivered free of charge.


35Nkr Unpaid letters couldn't be exchange directly but were sent through Switzerland to allow recovery of rate due to Italy. This letter from Vedano (21.1.62) to Cattaro, was charged on delivery 35kr: 10Nkr to Italy, 10Nkr to Switzerland and 15Nkr to Austria (third distance).



120cents

Single registered letter rate paid to destination "via Switzerland" from Modena (31.12.61) to Zamosuyvar. Registered letters had to double the single rate of 60cents: 20cents to Italy, 15cents to Switzerland and 25cents to Austria.

Single letter rate paid to destination "via Switzerland" from Florence (5.8.61) to Wien. In this period letters through Switzerland could be exchanged also from Tuscany at this rate: 20cents to Italy; 15cents to Switzerland and 25cents to Austria.

120cents Single registered letter rate paid to destination "via Switzerland" from Florence (14.3.62) to Baden. Registered letters had to double the single rate of 60cents.

Double letter rate (11grams) insufficiently paid, sent through Switzerland to allow recovery of the missing rate to Italy, from Milan (30.8.61) to Verona; charged on delivery 45Nkr: 30Nkr for double Italian and single Swiss rate plus 15Nkr for single third Austrian distance rate.


Double letter rate (11grams) insufficiently paid, from Milan (16.9.61) to Mantua; sent directly "via Desenzano" and not through Switzerland. Charged on delivery 8Nkr (for the double Italian rate; docketed: Art.20/ Diritto italiano C.mi 20) plus 5Nkr (inland first Austrian distance rate). It seems that from September 1861 there was money exchange between the two Postal Administrations.



Single letter rate from the first Austrian distance (up to 75km.) paid to the border, from Adria (31.3.61) to Bologna. Charged 2tenths on delivery (20cents of Italian lira) for domestic rate.



Single letter rate from the first Austrian distance (up to 75km.) paid to the border from Verona (22.6.61) to Desenzano. Charged 2tenths on delivery (20cents of Italian lira) for domestic rate.

Single registered letter rate (first Austrian distance) paid to the border, from Revere (2.6.61), to Milan. Charged on delivery 8tenths: 2tenths each 10grams (16grams weight, docketed on top left front side) plus 4tenths for Italian registration fee.



Single letter rate (second Austrian distance) paid to the Italian border from Venice (19.1.61) to Naples. Charged 2tenths in Italy and 5grana on delivery at Naples.

Single registered letter rate (second Austrian distance) paid to the Italian border from Venice (10.11.61) to Milan. Charged 8tenths on delivery: 4tenths for double weight (plus of 10grams but less of 1 Austrian lot, 17,5grams) plus 4tenths for the Italian registration fee.



10soldi Single letter rate (second Austrian distance), paid to the Italian border from Feltre (4.5.61) to Turin. Charged 4tenths on delivery for double letter rate, plus of ten grams weight but less than 17,5 grams (1 Austrian lot).



Single letter rate (second Austrian distance), paid to the Italian border from Feltre (14.5.62) to Milan. The letter starts one day before resumption of the Convention and arrives one day after resumption, so it was considered unpaid and charged on delivery 4tenths: rated as cover from first Austrian to second Italian distance according to the new Convention.



Single letter rate (third Austrian distance), paid to the Italian border from Tolmezzo (18.3.61) to Milan. Charged 2tenths on delivery for single letter rate. Second day of the Italian Kingdom.



15Nkr Single letter rate (third Austrian distance), paid to the Italian border from Wien (25.11.61) to Milan. Charged 4tenths on delivery for double letter rate (docketed 12grams/2 on top left front), plus of 10grams weight but less than 17,5grams (1 Austrian lot).



Double letter rate (third Austrian distance), paid to the Italian border from St. Lorenzen (30.12.61) to Naples. Charged 6tenths in Italy and 15 grana on delivery for triple letter rate, plus of twenty grams but less than 2 Austrian lots.





Single letter rate from Udine (9.7.61) to Recanati, sent "per Trieste" and from there "via di mare" with the Austrian Lloyd; paid 15soldi for the third Austrian distance and 10soldi for the Lloyd entitlements. Charged 05 bajocchi at Ancona (old Pontifical rate) converted in 2 tenths on delivery at Recanati.



6tenths

Single letter rate sent unpaid from Venice (21.2.62) to Brescia. Sent through the Switzerland and charged on delivery 25cents to Austria, 15cents to Switzerland and 20cents to Italy.



<u>35Nkr</u>

Single letter rate paid to destination through Switzerland (docketed 35 on the back side) from Cattaro (19.1.62) to Messina. Despite the St. Andrew cross indicating payment, barred on the front side, inexplicably sent via Desenzano and charged on delivery 2tenths for the Italian rate.

Single letter rate from the first Austrian distance, insufficiently paid from Venice (19.12.61) to Lovere. Sent through Switzerland to allow the recovery of the missing entitlements for Austria and Switzerland. Postage value completely lost and charged on delivery 6tenths: 25cents to Austria, 15cents to Switzerland and 20cents to Italy.



45Nkr Single letter rate sent through Switzerland, paid to destination, from Pola (22.3.62) to Saltrio, Como. The letter pays single Austrian and Swiss rate (15 + 10Nkr each Austrian lot) but double Italian rate (20Nkr) weighing more than 10 grams.



Double letter rate paid to destination from Guidizzolo (16.5.62) to Peschiera. Second day of resumption of the Convention; double 10cents rate for offices close together up to 15km.





From October 1, 1862 postage value were countered in charging on delivery.

Paid 4cents less ("CREDITO ITALIANO CENT.4") of the Italian entitlements (28cents every 15 grams) and charged on delivery 17Nkr; 15Nkr for triple first Austrian distance plus 4cents (rounded up to 2Nkr) for deficient Italian entitlements.



From October 1, 1862 postage value computed in charging on delivery.



Single registered letter rate paid to destination from Florence (20.1.63) to Wien. Second Italian to third Austrian distance: 65cents plus 40cents for the registration fee. The letter, suspected carrying money (that was found as "un quarto di Napoleone d'oro") was opened in Venice and not delivered. The Convention didn't allow sending money inside the covers.



Single printed matter (up to 17,5 grams) paid to destination, from Milan (14.9.62) to Trento.



Single letter rate paid to destination from Ficarolo (24.9.63) to Ferrara. Reduced rate for offices close together up to 15km.



10soldi Double letter rate paid to destination from Ficarolo (10.11.63) to Ferrara. Double reduced 5soldi rate for offices close together up to 15km.



Single letter rate insufficiently paid from Venice (17.5.62) to Ravenna. First Austrian to first Italian distance, charged on delivery 2,5tenths as unpaid letter. Third day of the convention's resumption.




Double letter rate correctly paid to destination, from Venice (18.5.62, one day later the cover above) to Ravenna. First Austrian to first Italian distance; we can read inside: "on the one of sixteen, I used the normal stamp, so you had to pay a small charge but nothing I knew about the "Lega" was resumed from fifteen nor indeed any information is affixed at the post office"!
